Dear Dr. Millspaugh,

Thank you for meeting with representatives of the Missouri Forest Resources Advisory Council (MoFRAC, or the Council) last August. The dedication of faculty and staff to the forestry profession and the education of young men and women was evident. The meeting was informative and helped us understand the current challenges facing natural resources higher education.

MoFRAC was established to facilitate communication among all who are interested in Missouri's forests to assure long-term forest health, productivity, and sustainability. Within this core purpose, MoFRAC serves as a sounding board or in an advisory capacity to agencies and organizations regarding forestry issues. Currently, more than thirty agencies and organizations are represented on the council, including the School of Natural Resources.

Missouri's 15.5 million acres of forestland support an \$8 billion timber industry in the state, providing nearly 43,000 jobs. Key among these jobs are professional foresters, who are responsible for forest management across public and private ownerships to provide economic benefits while supporting diverse wildlife habitat, healthy rivers, and recreational opportunities. Professional foresters are the face of forest management in the state, serving as the point of contact between landowners, timber harvesters, industry, and the public. While this requires a diverse set of skills, the foundational element is a robust forestry education.

MoFRAC understands there are significant challenges facing the School of Natural Resources and Forestry program. Among these is the capacity to maintain accreditation through the Society of American Foresters (SAF). The Council understands the School is considering a change in accreditation from the General Accreditation to the Natural Resources and Ecosystem Management program. The Council reviewed the standards for each accreditation path and believes the General Accreditation path gives graduates the strongest background and educational core needed to become competent forestry professionals. Unlike the Natural Resources and Ecosystem Management path, the General Accreditation ensures the essential forestry skills are included in the degree program. SAF accreditation is critical for graduates

from the School of Natural Resources Forestry program to compete in today's market for forestry professionals, and to maintain the University's reputation as a leader in forestry and related fields. Many employers either require or prefer an education from an SAF-accredited program. We hope you and the faculty will give strong consideration for maintaining the SAF General Accreditation.

One suggestion offered by MoFRAC members to help maintain the robust forestry education is to temporarily fulfill teaching needs not currently supported by full-time positions with forestry professionals. MoFRAC would like to emphasize the importance of filling full-time faculty vacancies, and offer this suggestion as an interim measure to maintain the continuity and rigor of the Forestry degree program while the School develops a long-term solution. We understand this is currently done on a limited basis, and would like to further discuss how to best meet the needs of students and the forestry profession under today's challenging circumstances.

Dr. Hank Stelzer represents the School of Natural Resources on MoFRAC and we look forward to receiving his updates on the accreditation process. To further discuss the School's status, the Council would welcome your attendance at any of our meetings, or we would be happy to meet with you on campus. MoFRAC looks forward to a response to this letter and we hope you take us up on our offer to meet with you.
